ORDER

As per U.O read (1) & (2) above, sanction was accorded to those Research Scholars who
had registered prior to July 2009 session to appear for the Ph.D Coursework examination.

The Syndicate at its meeting held on 12.02.2014 vide Item No.27.71 approved the
recommendations of the Standing Committee of the Syndicate on Research & Scholarships, to
grant one more chance in 2014 to those scholars who have been granted registration to Ph.D prior
to July 2009 session and failed to avail the chance already given to take up the course work
examination.

It was further resolved to follow the following modalities for such candidates who register
for the Ph.D Course Work Examination.

1. The last date for receiving application for course work examination of such candidates
in the University Office is 31st March 2014.
2. They shall pay an extra fee of Rs.1000/- in addition to the fee prescribed for taking
course work examination.
3. Those who want to opt out of the course work examination after submitting application
can do so and submit the thesis without course work No separate U.O exempting such
candidates from taking course work examination needed. They shall forward a
self- declaration to this effect at the time of thesis submission along with the copy of
the U.O granting permission to appear for course work examination.
4. The proposed course work examination can be taken by those scholars who have not
been awarded their Ph.D degree.
5. All other clauses and conditions in the U.O regarding course work examination till
date shall prevail.

Sanction has been accorded by the Vice-Chancellor to implement the above decision of the
Syndicate.


